ADDENDUM No 1

TO THE FINANCING AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF TURKEY AND THE COMMISSION OF THE EUROPEAN ON COMMUNITIES CONCERNING **PROGRAMME FINANCING** PARTICIPATION OF TURKEY IN THE ENPI BLACK SEA BASIN PROGRAMME UNDER THE IPA CROSS-BORDER CO-OPERATION COMPONENT, FOR THE **YEAR 2007**

The European Union (hereinafter referred to as "the Union"), represented by the European Commission (hereinafter referred to as "the Commission"), which is represented for the purposes of signing this amendment by Alexandra Cas Granje, Director of Directorate B in DG Enlargement.

and

The Government of the Republic of Turkey (hereinafter referred to as "the beneficiary country"), represented for the purposes of the signature of this amendment by the H. E. Ambassador M. Haluk Ilıcak, Undersecretary, Ministry for EU Affairs National IPA Coordinator (NIPAC)

of the other part,

Having regard to the Financing Agreement concerning the programme on financing the participation of Turkey in the ENPI Black Sea Basin programme under IPA Component II, for the year 2007 concluded between the Union and the beneficiary country (hereinafter referred to as "the Financing Agreement"),

HAVE AGREED AS FOLLOWS:

Article 1 - Nature and Subject

Black Sea Basin programme under the IPA Cross-border Co-operation component, for the year 2007 is extended by 24 months respectively. The execution deadline is 31 December 2014 and the disbursement deadline is 31 December 2015.

Following the adoption of the Commission Decision C(2012) 3663 on 31 May 2012 the execution period for the programme on financing the participation of Turkey in the ENPI

In the Article 6 (1) of the Financing Agreement, the execution deadline is modified accordingly:

The contracts must be executed within a maximum of 4 years from the end date of contracting.

Article 2

All other Terms and Conditions of the original Financing Agreement remain unchanged.

Article 3

Article 4 - Entry into force

This addendum to the Financing Agreement shall enter into force on the date of which the recipient notifies the Commission that all internal procedures in the Republic of Turkey necessary for the entry into force of this Agreement have been fulfilled.
