#### ADDENDUM No 1

TO THE FINANCING AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF TURKEY AND THE COMMISSION OF THE EUROPEAN COMMUNITIES CONCERNING PROGRAMME ON FINANCING THE PARTICIPATION OF TURKEY IN THE ENPI BLACK SEA BASIN PROGRAMME UNDER THE IPA CROSS-BORDER CO-OPERATION COMPONENT, FOR THE YEAR 2008

The European Union (hereinafter referred to as "the Union"), represented by the European Commission (hereinafter referred to as "the Commission"), which is represented for the purposes of signing this amendment by Alexandra Cas Granje, Director of Directorate B in DG Enlargement,

and

The Government of the Republic of Turkey (hereinafter referred to as "the beneficiary country"), represented for the purposes of the signature of this amendment by the H. E. Ambassador Haluk Ilıcak, National IPA Coordinator (NIPAC), of the other part,

Having regard to the Financing Agreement concerning the programme on financing the participation of Turkey in the ENPI Black Sea Basin programme under IPA Component II, for the year 2008 concluded between the Union and the beneficiary country (hereinafter referred to as "the Financing Agreement"),

HAVE AGREED AS FOLLOWS:

### Article 1 - Nature and Subject

Following the adoption of the Commission Decision C(2011)494 on 10 February 2011 the contracting and execution periods for the programme on financing the participation of Turkey in the ENPI Black Sea Basin programme under the IPA Cross-border Co-operation component, for the year 2008 are extended by 12 months respectively. The new contracting deadline is 2 July 2012 and the execution deadline is 2 July 2014.

In the Article 5 (1) of the Financing Agreement, the contracting deadline is modified accordingly:

The contracts which implement this Agreement shall be concluded no later than 3 years from the date of conclusion of this Agreement.

## Article 2

A new Annex C has been included, since the original Financing Agreement contained a wrong Annex C.



#### Article 3

All other Terms and Conditions of the original Financing Agreement remain unchanged.

## Article 4

This addendum to the Financing Agreement is drawn up in duplicate in the English language.

# Article 5 - Entry into force

This addendum to the Financing Agreement shall enter into force on the date on which it has been signed by both parties.
